Two held for shooting at Gau Raksha Dal volunteers: Police

TWO MEN who allegedly shot and injured two Gau Raksha Dal volunteers last month were arrested late Wednesday night, said Gurgaon Police. The shooting took place on June 25 morning when six volunteers of the group were attempting to confront alleged beef transporters on the Kundli-Manesar-Palwal Expressway.

Police identified the arrested men as Javed and Iklash. They were on a motorbike which was accompanying the vehicle suspected to be transporting beef

and had shot at the volunteers, said police. While one Gau Raksha Dal volunteer sustained injuries on his lower abdomen, the other was shot in the hand.

Police nabbed the two men following a tip-off that they would be at Indri Mod, Sohna, said sources. The two accused were involved in various criminal activities, the sources added. According to police, six stolen vehicles were seized from the accused. "They admitted to being behind crimes in several states, including Rajasthan and Haryana and have at least 20 FIRs lodged against them in different states," said Subhash Boken. PRO of Gurgaon Police, Thursday.

DELHI POLICE'S Special Cell has arrested two persons in connection with the murder of property dealer Kailash Gupta in northeast Delhi's Bhajanpura last month. Gupta was shot dead in broad daylight in Bhajanpura chowk on June 21. His son Rajan and three others were seriously injured in the attack.

Prime accused Sunil Pehalwan, who allegedly shot Gupta, was arrested along with his associate Sandeep Tyagi after police received a tip-off about their location.

Initial investigation has revealed that Pehalwan didn't want Gupta to depose against him, said police. "Gupta was the complainant and prime witness in his son's murder case. The accused were pressurising him to withdraw the case," said the DCP.

Moments before he was shot in a crowded area in Bhajanpura, Gupta, who was on a motorcycle along with his son, was talking on the phone. "It is yet to be ascertained if the man he was talking to was a co-conspirator," said Kushwah.

Gupta's younger son Rajan, a martial arts champion, had sustained severe injuries in the attack. Days after the incident, both his legs had to be amputated, as they were infected due to the bullet injuries.

A case under sections 186 (obstructing public servant in discharge of public functions), 332 (voluntarily causing hurt to deter public servant from his duty) and 353 (assault or criminal force to deter public servant from discharge of his duty) has

been registered. Both accused are residents of Lajpat Nagar.

DU admission process most bizarre: CM

CALLING THE admission system of Delhi University "most bizarre" Chief Minister Arvind Kejriwal Thursday said the central university does not have quota for city students, normalisation of marks or entrance tests. His remarks come days after his deputy Manish Sisodia wrote to former Human Resource Development Minister Smriti Irani, suggesting Delhi students should be given preference over those from other states in admission to DU. "Delhi University admission system is most bizarre. They don't

have either quota for locals or normalisation of marks or entrance tests," Keiriwal tweeted. In his letter to Irani, Sisodia

had said that due to "anomalies' in the admission process, lakhs of Delhi students were suffering.
